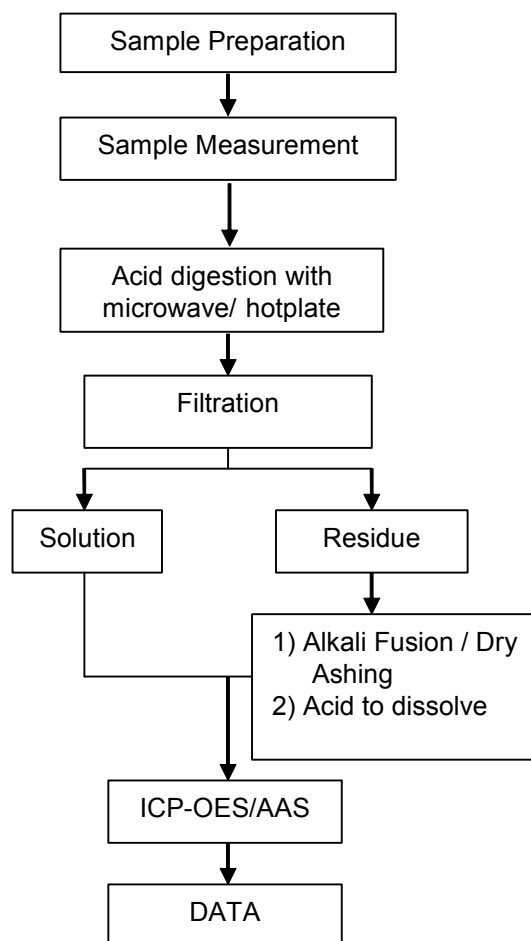

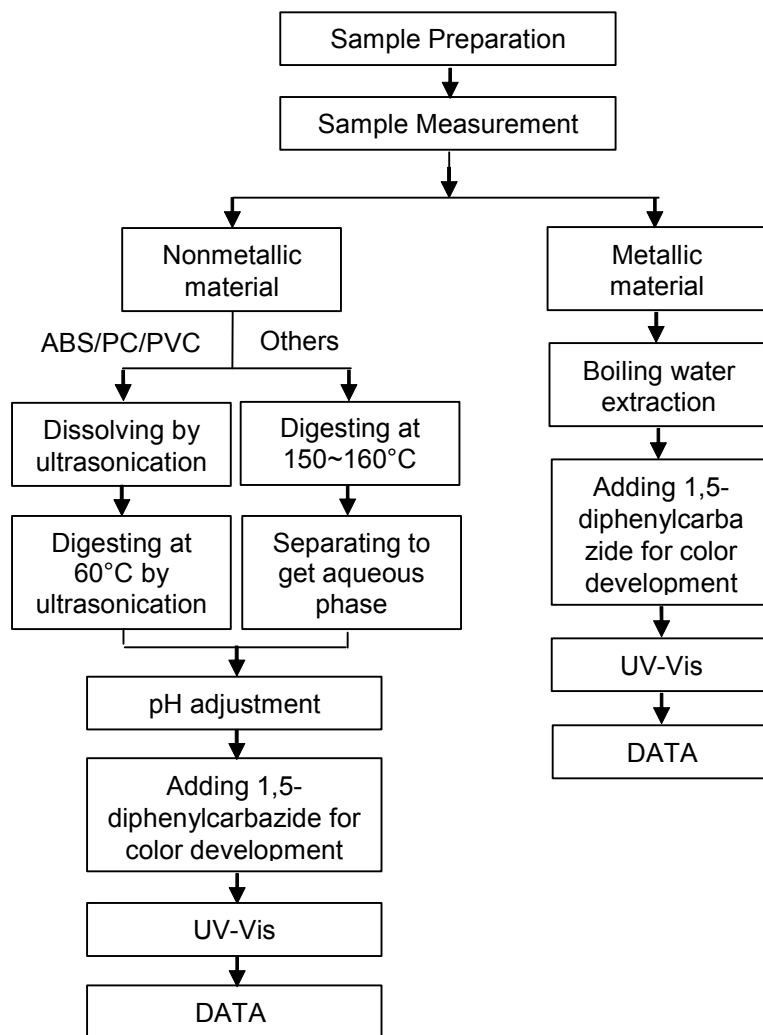

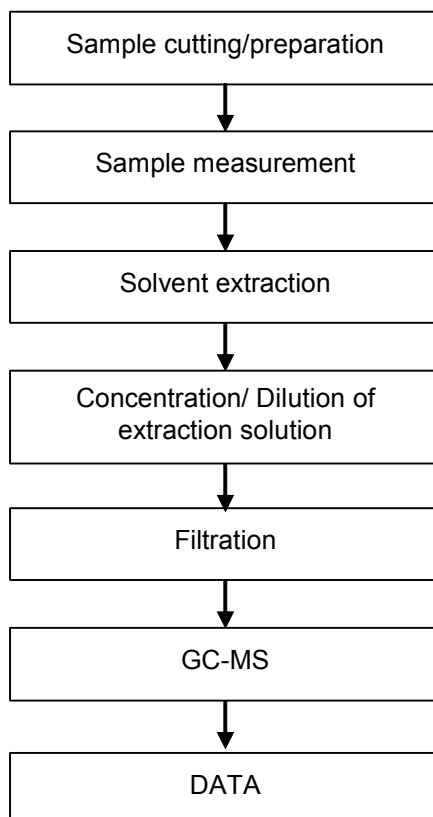

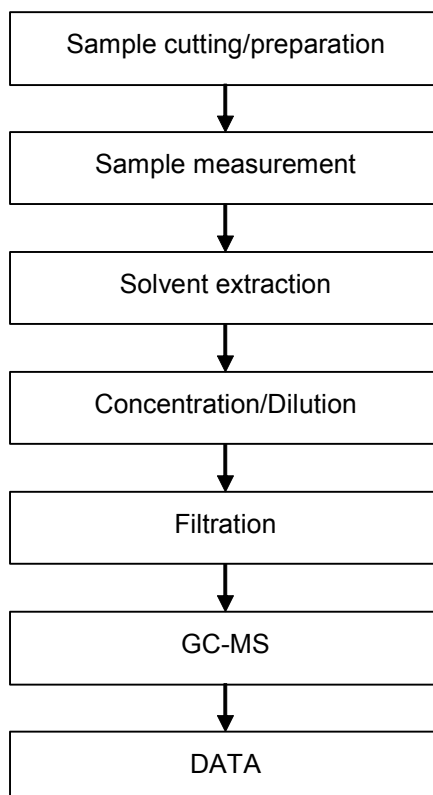

Phthalates Testing Flow Chart

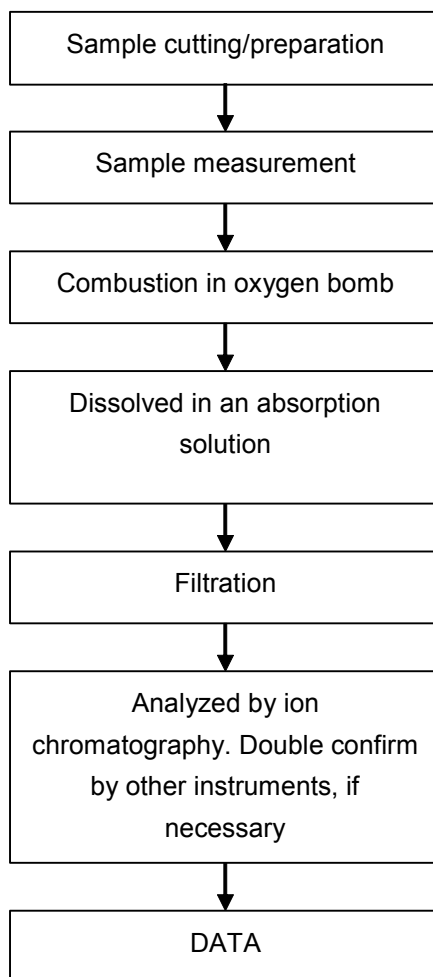

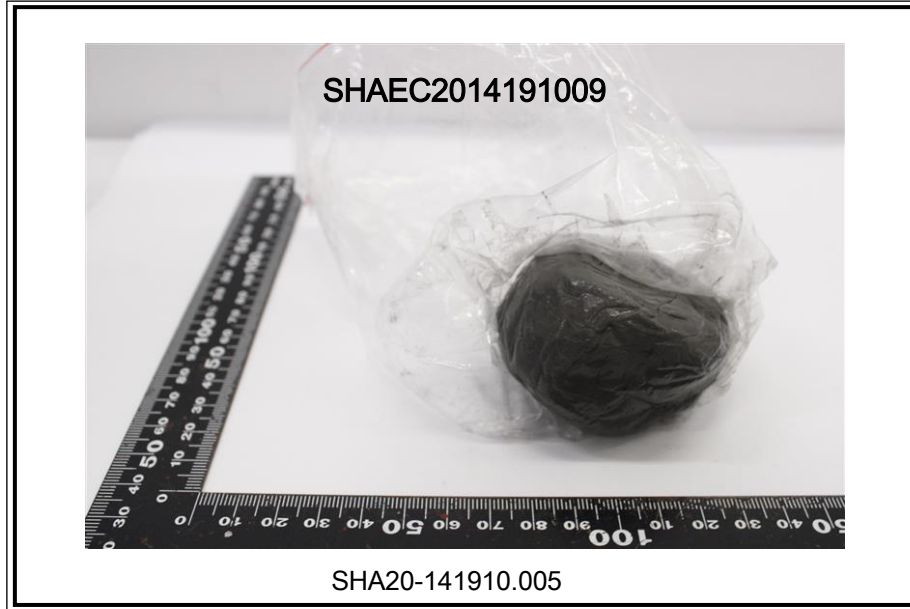
